Megasoft Limited Announces Third Quarter (Oct-Dec 2018) results

Financial highlights (Consolidated)

- Revenues for the quarter at Rs. 14.79 Crores
 - o Growth of 4.4% Quarter on Quarter
- Revenues for the first nine months at Rs. 43. 06 Crores (a drop of 14% over last year)
- Net Profit for 9 Months at Rs. 0.29 Crores (against a loss of Rs 1.03 Crores last year)

The last quarter saw an increase in revenue over the previous quarter, with two new deals getting closed. Also thanks to reorganizing its operations into SBUs, a "cash and caution" policy as well growth in South America, the Company managed to stay operationally cash & remain profit positive during the financial year. While the company continued to face decline in revenue year on year, Megasoft is confident of accelerated

growth in the medium term, as (i) MVNO and mobile payments market is showing an upward growth trend globally and (ii) new offerings have been launched in the fast growing IOT segment.

GV Kumar, Managing Director & CEO, Megasoft Limited said "While this transition from being a licensed Billing & Mobile Infrastructure company to one that caters to total infrastructure Solutions, mobile payments & Mobile enabled IOT solutions segments is resulting in short term revenue declines, in the medium and long term, the company is poised to grow well profitably especially with focused geographic approach, additional new product launches and focus on new business verticals and segments. Additionally, cash flows from Property will act as a cushion for the Company's operations, adding more financial stability."
